Dear Hat Island Owner:

We are sending you this letter to outline the 2024 Regular Assessment and “Optional” User Fees billing process for undeveloped lots. Options for making payments include paying by debit or credit card either online at hatisland.org, by phone or in person at the office, with VENMO or by mailing a check. Credit card transactions will be automatically charged a 3.5% service fee. We will be sending invoices by email for quarterly assessments and water bills. When you receive your invoice, you may also pay by clicking “View and Pay”. Please keep this letter for future reference. Assessment invoices will be emailed at the beginning of each quarter. If you would prefer a paper copy to be mailed to you, please notify the office. Regardless of the form of payment, please make sure your lot number is included.

Late fees will be applied according to the Collections Policy posted on the Hat Island website.
